**Waiver of hearing fees.* Persons who are unable to pay the hearing fee for hearing before the county planning and zoning commission, may request a waiver in the following manner:

1. Requests for waiver of hearing fees must be made in writing to the county board chair. The chair may request additional information deemed necessary to determine whether a financial hardship exists.
2. The chair will make a recommendation to be acted upon by the county board's executive committee. The applicant for waiver may be required by the committee to appear at the county board meeting.
3. The final decision of the county board regarding the waiver will be by motion and shall be delivered to the zoning office for its files.

4. The county zoning officer will schedule requests for waiver of hearing fees for hearing by the planning and zoning commission at the next meeting date that has at least one hearing scheduled.
