

## 2021 Assessment Publications

Assessment publications are going to be made September 21, 2021 in the Whiteside News Sentinel, Prophetstown Echo, Daily Gazette, Fulton Journal and Erie Review.

Assessment appeals must be filed by October 21, 2021 for any property in Whiteside County.

In a quadrennial year all assessments in a township are published. Quadrennial assessments were made this year in Albany, Garden Plain, Fulton, Fenton, Newton, Portland & Erie Townships.

In non-quadrennial years, only those assessments changed by an assessing official are published. Assessments changed by the application of a township factor are **not** required to be published.

Under authority of 35 ILCS-200-9-210, formerly chapter 120, Section 95A of the Illinois Revised Statutes, notice is given that all non-farm property has been reassessed for the 2021 assessment year by the application of the following factors:
